Absolutely NO CARS will be permitted at camp sites. All cars dropping off items at campers must be out by 9:00 am Monday or they will be towed. There will be no camper/exhibitor parking to the east of the horse practice arena or across the lane to the east of that area starting Thursday at 9 am. The fair has events that will be utilizing those areas. Towing will be at owner's expense.

Golf Cart permits may be applied for. Applications are available in the FairBoard office. A handicap permit, driver's license, and proof of liability insurance need to be brought to the office to be turned in with application. Permit will be given to those approved. The FairBoard will have utility carts available to help with moving feed and supplies 7-8:30 am & 5-6 pm. Please see FairBoard members for assistance. Any unauthorized vehicles will be required to be removed promptly.

Every person camping on the fairgrounds the week of the fair will be required to read and sign the code of conduct form. This form is available online, or in the office and must accompany the camping registration form.

Campers shall be solely responsible for any and all injuries to persons or damage of property or any other injury, claim, damage or loss of whatever nature, arising directly or indirectly from the event. Contractor shall INDEMNIFY, SAVE AND HOLD HARMLESS Sanilac County 4-H Agricultural Society and Fairboard and its employees, agents, and volunteers from and against all liability, loss, damages, claims, costs and expenses (including attorney fees) arising out of injury to person or damages to property or any other injury, claim, damage, loss, cost or expense arising from the event.
